Logs will scaled on one foot multiples and using the Official Log Scaling and Grading Rules (as adopted by the Northwest Log Rules Advisory Group).

Pole Sorts: Enter two or more preferred log lengths. Log lengths exclude trim. Trim will be a minimum of 12 inches. Trim will be a maximum of 18 inches. Logs will scaled on two foot multiples and using the Official Log Scaling and Grading Rules (as adopted by the Northwest Log Rules Advisory Group).
