Design and construction of a performance area for musical, theatre and local events in Patterson Park.

#### **Project Background and Objectives**

The Town of La Ronge as part of a revitalization of Patterson Park and capital improvement budget allocations will be contracting the development of a performance area in Patterson Park.



Goals of this project are:

- Provide a space for organized and unorganized performance arts in the park;
- Activate underutilized park space, creating an attraction for positive social behaviours;

Patterson Park is located an Parcel BB Plan 101816399 and Parcel B Plan CN1121 southeast of La Ronge Avenue (approximate performance area location: 55.102921,-105.282876).

#### **Description of the Work**

Construct a visually appealing and complementary structure to highlight the natural beauty of the park and lakefront setting.

The Work includes but is not limited to the following: General:

- a) Mobilization, demobilization, site safety, administration, site clean-up, warranties, general requirements, barriers, temporary works, protection, signage, traffic control, coordination, etc.;
- b) Acquisition of permits and licenses required to complete the work;
- c) Coordination where necessary with the Town Project Manager;
- d) All labour, equipment, tools and transport required to complete work is to be provided by the Contractor;
- e) Any damage that may occur is to be repaired by the Contractor to match the pre-existing condition; and
- f) Contractor is responsible for all disposal/landfill fees;
- g) Contractor is responsible for any preliminary site visits required to determine site conditions. Should the contractor wish to investigate land suitability the Town should be contacted in advance for permission for any ground disturbance.

#### Design:

- a) Offers some protection from weather and sun for performers;
- b) Provides a minimum 24 feet wide by 16 feet deep space/footprint for performers and equipment;
  - (i) If footing or base material is proposed to be a concrete pad or similar, it is expected the contractor inspect the site and include in the proposal how the structure would be tied into the existing concrete base at that location.
- Honours local context using materials that mimic the natural setting or design that is inspired by the park, the Town and local history;
- d) Be engineered to withstand typical snow load and local weather;
- e) Have as part of the design, or be able to integrate lighting and power to be installed permanently;
  - (i) Power service will be provided within close proximity to the site.
- f) Use materials/design/construction methods that are resistant to vandalism;
- g) May include design for removable panels or structural components that enclose one or more sides to project sound or provide increased protection from the weather. When not in use, the performance area is to be an open



back, with the option of additional wall panels that can be folded up or removed/installed for events.

(i) Any removable components must be easily transported to storage facility with typical municipal vehicles.


