Article I. INTRODUCTION AND BACKGROUND

The Town of La Ronge (Town) is requesting proposals to purchase a new refuse transfer truck to fulfill the demands of the refuse pick up service. The Town is a municipality of approximately 3000 people and is located 250km north of Prince Albert. The Town carries out curb side front-street refuse pick up for 837 residents. Requested general specifications for this purchase are listed in Article III.

- i) Minimum two (2) rear strobes, two (2) front strobes, one (1) switch activated top strobe
- j) Work lights illuminating all monitoring areas
- k) Bedliner undercoating under truck
- I) Fenders for rear tires
